

NOTICE OF PUBLIC MEETING

American Structurepoint, Inc., acting on behalf of the Town of Avon, will hold a public information meeting for the Dan Jones Road Widening Phase 3 Project (Des. No. 2202FFE) **Wednesday, November 1, at 6:00 pm.** The public information meeting will commence promptly at 6:00 PM with a presentation followed by an open house that will conclude at 7:30 PM. The meeting will be held at Kingsway Christian Church, located at 7981 East County Road 100 North, Avon, Indiana. Meeting materials will be posted to the website by November 1, 2023. All comments are requested by December 1, 2023.

The purpose of the public information presentation is to offer all interested persons an opportunity to review and comment on the project. The project limits begin at the intersection of Dan Jones Road and Rockville Road (US 36) and extend north approximately 1.03 miles before terminating at the intersection of East CR 100 North (West 10th Street) and Dan Jones Road, in Avon, Hendricks County, Indiana. The current scope of work will include the reconstruction of Dan Jones Road from a 2-lane Minor Arterial to a 4-lane roadway. The typical roadway section is anticipated to consist of four (4) 12-foot-wide travel lanes (two in each direction), with a 14-foot-wide raised median, curb and gutter, 10-foot multi-use path on the east side, and a 6-foot sidewalk on the west side. The 14-foot raised median would transition to a left-turn lane as warranted at intersecting roadways. The need for the Dan Jones Road Reconstruction Project is evident based on the existing low level of service of the roadway, the ongoing growth in the area, and resulting anticipated traffic volumes. The purpose of the project is to improve the roadway so that it can effectively accommodate future traffic volumes and operate at an acceptable level of service during the design year.

The maintenance of traffic plan is for this project to be phased and maintain single-lane traffic in both directions during the construction period. Access to all properties will be maintained throughout construction. Project stakeholders including local school corporation(s) and emergency services will be notified of potential closures and/or detours prior to any construction. Construction of the project will require new permanent right-of-way. Local and State funds are to be utilized for the construction of the project.

With advance notice, the Town of Avon can provide special accommodation for persons with differing abilities, limited English speaking ability, and/or persons needing auxiliary aids or services such as interpreters, signers, readers, or large print.
