Project Description

American Structurepoint Inc., on behalf of Warrick County, are developing plans for the proposed Anderson Road and Vann Road Intersection Improvement Project located in Newburgh, Warrick County, Indiana. The project is specifically located at the Anderson Road and Vann Road intersection, extending approximately 600 feet from the intersection in each direction.

The need for this project is to reduce congestion, improve mobility through the intersection, and increase safety.

As proposed, a single-land roundabout will be constructed as Anderson Road and Vann Road. Adding lighting around the intersection will improve visibility for drivers approaching the roundabout. A pedestrian path will be constructed through the splitter island on the north leg of the intersection to maintain the existing pedestrian crossing.

Description of Right-of-Way

The project will require the acquisition of right-of-way. Acquisition information can also be viewed at the project website at www.structurepointpublic.com/AndersonandVann. The project will require approximately 0.934-acre of permanent new right-of-way and 0.306 acre of temporary right-of-way from the properties along the east and west sides of Anderson Road.

Estimated Project Cost

The estimated cost for this project is \$2.3 million which includes design, right-of-way, and construction costs. Local funding will be used.

Maintenances of Traffic (MOT)

The MOT plan for the project involves a full closer of the intersection during construction with local detours established to route traffic around the closure. MOT details will be presented during the public meeting. Access to all properties will be maintained during construction. Warrick County will coordinate with emergency services, local school corporation officials, and project stakeholders to ensure potential disruptions and impacts are minimized as much as possible.

Water Resources

A wetland delineation was completed on October 18, 2022 that identified any water resources within the project area. It was determined that two wetlands, Wetland A-1 and Wetland A-2, and one pond, Pond 1, were located within the project area. Both Wetlands and the pond would likely be considered jurisdictional waters of the U.S. The U.S. Army Corps of Engineers (USACE) makes all final determinations regarding jurisdiction.

Wetland A-1 is located in the southeastern quadrant of the investigated area. Approximately 0.01 acre of permanent wetland impacts are anticipated to Wetland A-1 for the placement of fill. Wetland A-2 is also located in the southeastern quadrant of the investigated area. Approximately 0.052 acre of permanent wetland impacts are anticipated to Wetland A-2 for the placement of fill. Due to the placement of fill within the wetlands, a Section 401 Regional General Permit (RGP) from Indiana Department of Environmental Management (IDEM) and a Section 404 RGP from the USACE are anticipated for impacts to waters of the U.S. Complete avoidance of the wetlands were not practical due to the shifting of the intersection to avoid impacts to the residential area and religious facility.

Pond 1 is located in the southwestern quadrant of the project area, outside of the construction limits of the project. No impacts are expected.
