## **Notice of Public Information**

The Commissioners of the County of Allen, with funding from the Federal Highway Administration (FHWA) and administrative oversight from the Indiana Department of Transportation (INDOT) intends to proceed with Phases 3B and 3C of the Bass Road Reconstruction Project, Des. No. 1901699 (Lead), 1401273, and Parent Des. No. 0400582 near Fort Wayne, Allen County, Indiana.

The Bass Road Reconstruction project (Des. No. 0400582) is an approximate 4.4-mile corridor beginning just west of Scott Road and continuing east to the intersection of Hillegas Road. A Categorical Exclusion Level 4 was approved for the overall project on August 22, 2012. Four subsequent Additional Information documents have been approved in 2016, 2019, 2020, and 2021 describing the seven phases of construction and modifications to the project.

Since the approval of the above environmental documents, three phases (Phases 1A, 2A, and 2B) have been constructed and are currently open for use, two phases (Phases 1B and 3A) are under currently construction, and two additional phases (Phases 3B and 3C) remain to be constructed. This document is intended to provide an update to the project status and the anticipated schedule of Phases 3B and 3C.

Phase 3B begins approximately 1,800 ft east of the intersection of Wescott Drive and extends west before ending 767 ft west of Brenton Glens Drive. Phase 3C begins 767 ft west of Brenton Glens Drive and ends just west of Scott Road. Phases 3B and 3C anticipated to move to construction in the spring of 2023 under one contract. Construction is anticipated to continue through 2025.
