## NOTICE OF PROJECT ADVANCEMENT – Dan Jones Road Reconstruction Project (Des. Nos. 1801463, 1901763, 2001663)

## February 2022

American Structurepoint, Inc., acting on behalf of the Town of Avon, held a public hearing in November 2021 for a proposed improvement project located at Dan Jones Road, beginning 25 feet north of Oriole Point Drive and extending approximately 1.24 miles north before ending 370 feet north of the intersection at Main Road in Avon, Hendricks County, Indiana. The project area also extends west for approximately 0.1 mile along the intersecting roadways of County Road (CR) 100 South and CR 150 South (Oriole Way). This public hearing was held as part of the environmental analysis phase as required per the National Environmental Policy Act (NEPA). Public involvement is an important element of a comprehensive decision-making process. The need for the Dan Jones Road Reconstruction project is evident based on ongoing growth in the area and resulting anticipated traffic volumes. The purpose of the project is to improve the level of service of the roadway to accommodate future traffic volumes as well as improve pedestrian access.

The current scope of work will include the reconstruction of Dan Jones Road from a 2-lane minor arterial to a 4-lane roadway. The roadway is anticipated to be widened to the east and west equally from the existing centerline. The typical roadway section for Des. Nos. 1801463 and 1901763 is anticipated to consist of four (4) 12-foot wide travel lanes (two in each direction), with a 15-foot wide raised median, curb and gutter, 10-foot multi-use path on the east side, and a 6-foot sidewalk on the west side. The 15-foot raised median would transition to a left turn lane as warranted at intersecting roadways. The sidewalk and multi-use path will be separated from the road by a 5-foot wide grass buffer strip. The Des. No. 1901763 project also includes construction of a 2-lane roundabout at the intersection of Dan Jones Road and CR 150 South, and Des. No. 2001663 will include the reconstruction of Hendricks County Bridge 251 (NBI No. 3200251).
